

## COMPASS Privacy Policy

The COMPASS Privacy policy is way more than collecting your data, its about ensuring your confidentiality as a caregiver/clinician is also protected. Sadly, there is still a significant stigma in healthcare about expressing the stress related to being a caregiver. COMPASS will never require you to divulge any information to be part of the emotionally healing process.

### **What type of information do we collect?**

*We receive, collect and store any information you enter on our website or provide us in any other way. In addition, we collect the Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information and purchase history. We may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page. We also collect personally identifiable information (including name, email, password, communications); payment details (including credit card information), comments, feedback, product reviews, recommendations, and personal profile.*

*In addition, we conduct scientific research, in accordance with all applicable ethics and federal laws. Any data collected for research purposes will be housed separately in accordance with Safe Harbor Data Protection, and will not be associated with the website.*

### **How do we collect information?**

*When you conduct a transaction on our website, as part of the process, we collect personal information you give us such as your name, address and email address. Your personal information will be used for the specific reasons stated above only.*

*We do use cookies, but provide an opt-out option on our website.*

### **Collecting personal information:**

*We collect such Non-personal and Personal Information for the following purposes:*

- 1. To provide and operate the Services;*
- 2. To provide our Users with ongoing customer assistance and technical support;*
- 3. To be able to contact our Visitors and Users with general or personalized service-related notices and promotional messages;*

4. *To create aggregated statistical data and other aggregated and/or inferred Non-personal Information, which we or our business partners may use to provide and improve our respective services;*
5. *To comply with any applicable laws and regulations.*
